

## Acceptance and Commitment Therapy: Process in Clinical Practice Pre-Meeting Institute

### **Description:**

Acceptance and commitment therapy (ACT) employs a variety of verbal and experiential processes and techniques to assist clients in making life-enhancing choices based on personally held values. ACT, as a modern behavioral approach within the third wave of cognitive-behavioral therapies, emphasizes psychological flexibility, helping clients live in alignment with their values in the service of creating meaningful living. This training aims to deepen participants' understanding of how ACT promotes resilience and adaptive coping by encouraging clients to open up to difficult experiences instead of avoiding them. Attendees will gain insights into fostering an accepting, value-driven therapeutic relationship and experience ways to integrate mindfulness and experiential exercises within their practice, assisting the client to live meaninfully. Using case examples and role-play, participants will be equipped with practical tools to help clients cultivate awareness, respond flexibly to life challenges, and pursue meaningful goals. #### **Learning Objectives:**

Following the training, attendees will be able to:

- 1. Explain the six processes that underlie psychological flexibility/inflexibility.
- 2. Analyze the language-based processes (e.g., RFT) that create suffering.
- 3. Use "creative hopelessness" to motivate a change in the control agenda.
- 4. Explain how acceptance and defusion support openness to experience.
- 5. Integrate the concepts of present moment and self-as-context into the process of establishing awareness.
- 6. Analyze how values and commitment action can support meaningful living.
- 7. Develop strategies for implementing ACT processes across various client presentations and contexts.



- 8. Evaluate the state of ACT as an evidence-based treatment.
- 9. Demonstrate perspective-taking and its relationship to creating flexibility.
- 10. Apply committed action and values clarification together to create meaning and behavioral goals.
- 11. Use ACT to address multiple clinical issues and presenting problems.
- 12. Analyze the essential characteristics of the therapeutic relationship from an ACT point of view, including intrapersonal and interpersonal processes.
